Badgerland Gordon Setter Club - Field Trial - August 23 & 24th 2008

FIELD TRIAL

Held at Pine Island Field Trial grounds, Portage, WI

Badgerland Gordon Setter Club held their first "Setters only" format Field Trial. The Pine Island Field Trial grounds located in Portage, WI offers a superb area to hold a trial. There is only one small hitch, it's located in a flood plane. South Central Wisconsin has experienced some of the worst flooding in over a century. Just last August we had canceled our trial due to water. About 20" fell in the 10 days leading up to last year's date.

This year the record rains fell in June, following a record winter for snowfall. 




